In regard to the expenditure of the highway money, I wish to say that the roads were in rather bad shape last spring, which necessitated quite an outlay of money. I

worked all the roads in town, with the exception of about three miles, with the road machine at an expense of about \$950.00.

Cost of cutting brush in the highway, about \$55.00.

Expended in getting rocks out of the highway, about \$100.00.

There was nearly 700 loads of gravel and other road material drawn onto the roads at a cost of about \$275.00.

Of the 326 sluices in town 51 have either been built new or thoroughly rebuilt at an expense of \$280.00.

The balance of expenditure is in miscellaneous repairs.

There are in my possession, belonging to the town, two blades and one arm for the road machine, three bars, one pick, one stone hammer, four shovels, one wrench, three hooks, one small hammer and about \$10 worth of dynamite. The road machine has been put in good repair for next year's use.
